

PRECISION PITCHING ACADEMY LESSON CONTRACT POLICIES (page 1 of 2)

Please read carefully and complete and sign all categories of the contract sheet on page 2

Terms and Conditions: We hereby understand that all softball lessons will be held at the assigned time slots and dates that are listed on the included calendar. We understand that the participant will remain in her assigned time slot every lesson. We understand that payment and the completed waiver form must be received by the instructor prior to the first lesson or else the participant will not receive a reserved time slot. We understand that once the participant has been granted a reserved time slot and payment has been received by her instructor there will be NO REFUNDS.

Absentee Policy: We need AT LEAST a minimum of 24 hour notice in order to reschedule your lesson for you. If we are given less than 24 hour notice we will try our best to make arrangements, but if we cannot get another student to fill your missed slot then we CANNOT grant you a make-up lesson. Please understand that all rental space is paid for a month in advance with the facility so we cannot be refunded for that rental space if you miss your lessons. Also, each instructor must receive payment for her time she has set aside for lessons regardless of whether the student attends.

All make-up lessons MUST be completed during the same session, unless the participant has an injury or illness with a doctor's note stating that she is not allowed to participate in lessons during that session, and the note must specifically list all dates that she is to be out. If we do not receive a doctor's note for our records this policy holds. We will not be carrying credit or issuing refunds for future sessions. If the participant cannot do her make-up lesson on one of the dates that her instructor offers, then she will be required to complete her make-up lesson with another instructor in our Precision Pitching Academy group.

(NOTE: Credit means that I will withhold the dollar amount of lessons that are still remaining at the time I receive the doctor's note and the participant can receive her lessons at a later date once she has been released by her doctor to return to lessons.)

Injury Policy for all Participants: We acknowledge that at Ballplayer's Edge of New Jersey and Primo Sports of New York, the softball clinics I or my child will be participating in may involve, among other things, physical contact of the body with other persons or objects, including the ground, softballs, softball bats, pitching mats, pitching mounds, and strength training equipment, and at the above listed facilities me or my child may incur a risk of injury. I specifically waive and give up and release Precision Pitching Academy and all employees, Ballplayer's Edge of New Jersey, Primo Sports of New York, Kristyn DePasquale-Plunkett, Jamie Turton, Jessica Crum, Dana Nielsen, Breanne Berger, Brittany Blohm, Mary Mastrianni, and Emilyrose Havrilla from liability for any claim or damages which I or my child may have for injuries or illness that he/she and/or myself may sustain at lessons.

IMPORTANT: If this contract is not signed and dated by both the legal guardian(s) of the participant and the participant herself in all necessary areas, the participant will not be permitted to attend lessons until this is resolved. Catchers will not be permitted to catch for the pitcher until the catcher and his/her legal guardian sign the section of the attached contract entitled "Injury Policy for Catchers." If the catcher is 18 or older, the legal guardian of the catcher is not required to sign this portion of the contract.
